Board members opened quotes for the Crawfordsville Storm Water North Ridge Project. They received two quotes. Busses Excavating in the amount of \$138,500 and Price Excavating in the amount of \$132,920. Mayor Barton moved to take the bids under advisement. Erin Corbin seconded. Motion passed.

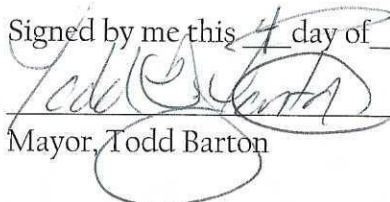
