Board members discussed an amendment to the construction agreement between the City and Plant Brothers Excavating and Construction Co., LLC. This agreement is stating that the contractors work must be substantially completed by May 31, 2024 and be operational by or

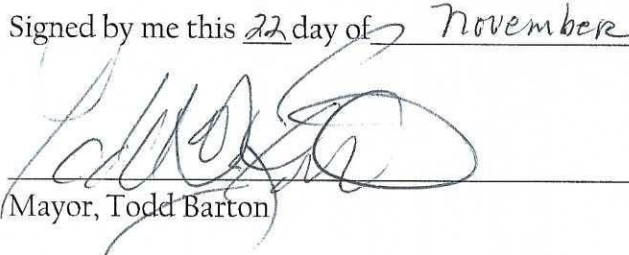

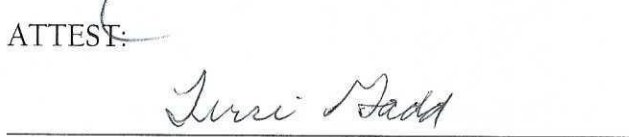
With there being no further business, Erin Corbin moved to adjourn. Susan Albrecht seconded. Motion passed and the meeting was adjourned.
