The Board met on Wednesday, March 8, 2023, at 10:00 a.m. with Mayor Barton, Erin Corbin, Susan Albrecht and Kent Minnette - City Attorney present. Also present were Mike McKinney - Wastewater, Mark Cox - Street Department, Aaron Mattingly - Police Department, Scott Busenbark - Fire Department, Fawn Johnson - Park & Rec, Megan Huckstep - Planning Department, Allison Huenemann - CEL&P and Renee Demoret - Mayor's Assistant.

Susan Albrecht moved to approve the minutes from March 1, 2023. Erin Corbin seconded. Motion passed.

Erin Corbin moved to approve the claims from March 6, 2023. Susan Albrecht seconded. Motion passed.

Old Business

Board members discussed the bids received for the construction of the Alley Activation Project. Tracy Mobley is recommending to award the bid to Spencer Construction in the amount of \$224,300. Susan Albrecht moved to approve. Erin Corbin seconded. Motion passed.

New Business

Leann Parish, Wabash College, came before the board requesting to close Pike Street at Pike Place on April 1st from 10 am - 4 pm for "The Alliance" event from 12 - 3 pm. Erin Corbin moved to approve. Susan Albrecht seconded. Motion passed.

Board members discussed a request from Derek Griggs to place a dumpster at 602 S. Green Street beginning Wednesday, March 8 thru Saturday, March 18th. Susan Albrecht moved to approve. Erin Corbin seconded. Motion passed.

Board members discussed a request from Price Excavating to close Big Four Arch Road for two weeks beginning Monday, March 13th. The road will be closed from Scheck Road to Russel Avenue while still allowing LSC employees, AVL & home owner's access. Erin Corbin moved to approve. Susan Albrecht seconded. Motion passed.

Board members received quotes for a Chevy Equinox for the Crawfordsville Fire Dept. Mayor Barton moved to table. Erin Corbin seconded. Motion passed.

Board members discussed a resolution approving acceptance of donation of certain real property under Indiana code 36-1-4 and designating "Constitution Row" a public way and street of City of Crawfordsville. This is the street leading to the new government center. The land owner is donating the property to the City and this is the formal process to accept the donated property. The City will maintain the street. Susan Albrecht moved to approve. Erin Corbin seconded. Motion passed.

Board members discussed an agreement between the City and Ballfield Renovations LLC. This agreement is for Baldwin Field & Welliever Field in the amount of \$29,750. Erin Corbin moved to approve. Susan Albrecht seconded. Motion passed.

Board members discussed an emergency tree removal at 718/720 South Grant Avenue. The tree is in the right of way and between two power lines. The City is not comfortable removing the tree. Barry Lewis, Code Enforcement Officer, is requesting to have J&D Tree Service remove the tree in the amount of \$2,000. Susan Albrecht moved to approve. Erin Corbin seconded. Motion passed.

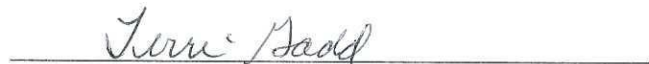
With there being no further business, Erin Corbin moved to adjourn. Susan Albrecht seconded. Motion passed and the meeting was adjourned.
