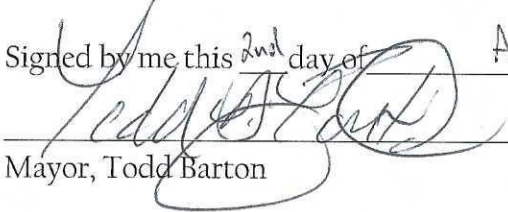
Miscellaneous
