The remaining 5 properties need to be mowed. Erin Corbin moved to approve. Susa Albrecht seconded. Motion passed.

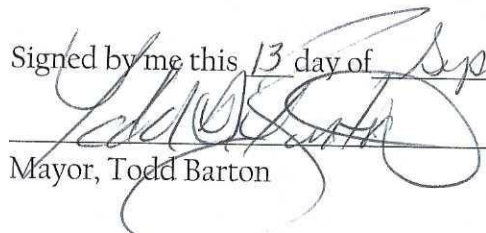
