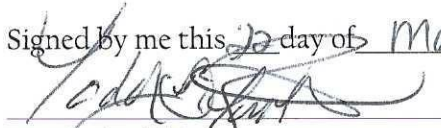

Paul Miller, Fire Department, wanted to remind everyone that the Blood Drive is today.

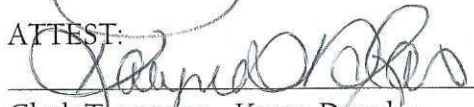
#### Adjournment
