Susan Albrecht moved to approve. Erin Corbin seconded. Motion passed.

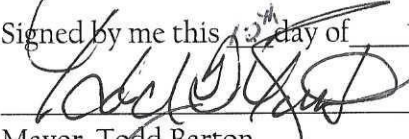

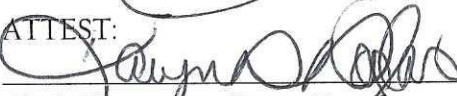
Adjournment
