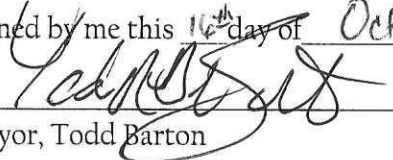
Miscellaneous

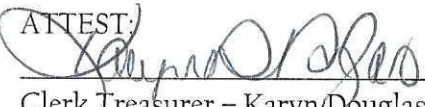
