This is in regards to Purple Heart Parkway and Schenck Road in the amount of \$112,500 split between City and County. Erin Corbin moved to approve. Susan Albrecht seconded. Motion passed.

Board members discussed change order #3 for Purple Heart Parkway in the amount of \$5,670.70. Susan Albrecht moved to approve. Erin Corbin seconded. Motion passed.

Board members discussed an agreement between the City and INDOT for the installation of Wayfinding Signage. Erin Corbin moved to approve. Susan Albrecht seconded. Motion passed.

Mayor Barton moved to take the bids under advisement. Susan Albrecht seconded. Motion passed.

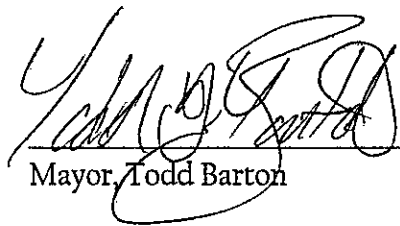

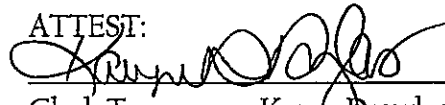
With there being no further business, Susan Albrecht moved to adjourn. Erin Corbin seconded. Motion passed and the meeting was adjourned.
