The Board met on Wednesday, November 27, 2024, at 10:00 a.m. with Susan Albrecht, Erin Corbin, Mayor Barton and Kent Minnette - City Attorney present. Also present were Karyn Douglas - Clerk Treasurer, Fawn Johnson - Park & Rec, Mike McKinney - Wastewater, Ed Maguey - Street Department, Aaron Mattingly - Police Department, Megan Huckstep - Planning Department, Allison Huemman - CELP&P, Paul Miller - Fire Department and Renee Demoret - Mayor's Assistant.

Susan Albrecht moved to approve the minutes from November 20, 2024. Erin Corbin seconded. Motion passed.

Erin Corbin moved to approve the claims from November 25, 2024. Susan Albrecht seconded. Motion passed.

Old Business

Board members discussed an unsafe building order for 117 E. Market Street. Mayor Barton moved to extend the order until January 8th. Susan Albrecht seconded. Motion passed.

New Business

Tim Jones came before the board requesting to block a portion of the sidewalk at 220 E. Market Street on Wednesday, December 4th with a backup date of Thursday, December 5th for repairs to the building. Susan Albrecht moved to approve. Erin Corbin seconded. Motion passed.

Board members discussed the 2025 Wastewater Budget. The budget has a 5% increase over 2024 in the amount of \$4,621,390. Erin Corbin moved to approve. Susan Albrecht seconded. Motion passed.

Board members discussed the 2025 Storm Water Budget. The budget has a 10% increase over 2024 in the amount of \$828,903. Susan Albrecht moved to approve. Erin Corbin seconded. Motion passed.

Board members discussed the 2025 Sanitation Budget. The budget has a 7% increase over 2024 in the amount of \$381,545. Erin Corbin moved to approve. Susan Albrecht seconded. Motion passed.

Board members discussed the 2025 Central Garage Budget. The budget has a 4% increase over 2024 in the amount of \$374,153. Susan Albrecht moved to approve. Erin Corbin seconded. Motion passed.

The City of Crawfordsville acknowledges its responsibility to comply with the Americans with Disabilities Act of 1990. 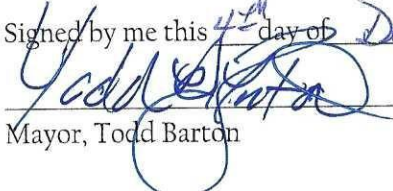

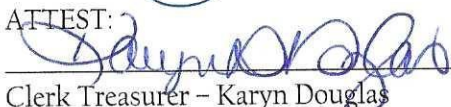
