Miscellaneous

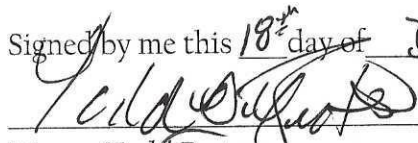
Department Heads
