Susan Albrecht moved to approve the minutes from February 5, 2025. Erin Corbin seconded. Motion passed.

Board members discussed the consideration of performance and/or maintenance bonds for Hawkview Section 1. Discussion arose. Susan Albrecht moved to approve. Erin Corbin seconded. Motion passed.

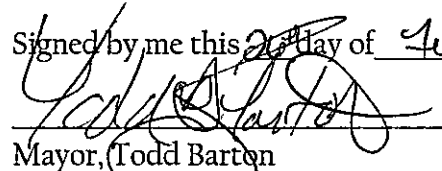

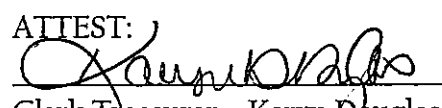
With there being no further business, Erin Corbin moved to adjourn. Susan Albrecht seconded. Motion passed and the meeting was adjourned.
