The Board met on Wednesday, May 21, 2025, at 10:00 a.m. with Erin Corbin, Mayor Barton and Kent Minnette - City Attorney present. Also present were Fawn Johnson - Park & Rec, Mike McKinney - Wastewater, Mark Cox - Street Department, Aaron Mattingly - Police Department, Megan Huckstep - Planning Department, Allison Huemman - CELP&P, - Scott Busenbark - Fire Department and Renee Demoret - Mayor's Assistant.

Erin Corbin moved to approve the minutes from May 14, 2025. Mayor Barton seconded. Motion passed.

Erin Corbin moved to approve the claims from May 19, 2025. Mayor Barton seconded. Motion passed.

Old Business

Board members discussed the acceptance of the bids for the Community Crossings 2025-1. Brandy Allen asked to accept Grady Brothers in the amount of \$655,020.16 split between the City and INDOT. Erin Corbin moved to approve. Mayor Barton seconded. Motion passed.

Board members awarded BCA Environmental Consultants for the Brownfields Grant. Erin Corbin moved to approve. Mayor Barton seconded. Motion passed.

New Business

Board members discussed a request from Price Excavating to close the southbound lane on Water Street from Main Street to the alley & three parking spaces on Main Street in front of the Ben Hur building for sidewalk work. The closure will begin Wednesday, May 21 through Friday. Erin Corbin moved to approve. Mayor Barton seconded. Motion passed.

Board members discussed a request from Price Excavating to close Tuttle Avenue from John to Wallace on Monday, May 26th for one day to repair a collapsed sewer. Erin Corbin moved to approve. Mayor Barton seconded. Motion passed.

Mark Cox, Street Commissioner, is requesting to surplus 2 paint machines a 1994 Graco GM3500 and a 2011 Graco LL IV 3900. Erin Corbin moved to approve. Mayor Barton seconded. Motion passed.

Board members discussed an agreement between the City and Mary Glass MD for medical direction services related to Mobile Integrated Health. This agreement is in the amount of \$150 per hour not to exceed \$11,000. Erin Corbin moved to approve. Mayor Barton seconded. Motion passed.

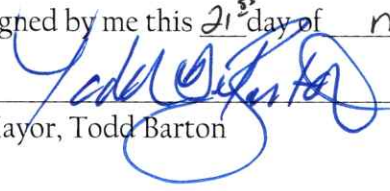

Adjournment

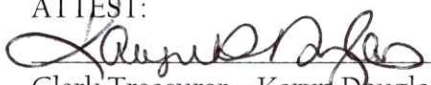
With there being no further business, Erin Corbin moved to adjourn. Mayor Barton seconded. Motion passed and the meeting was adjourned.
